DEVELOPMENT COMMITTEE

- 1. Reviewed LCIF fundraising achievements totaling US\$187.1 million in cash donations and pledges (unaudited), representing 84% of the June 30, 2021 benchmark of US\$223.5 million.
- 2. Amended the LCIF Operations and Policy Manual Exhibit D (Forms of Recognition) to state that a Leo-Lions Share pin be used recognize Leos who contribute a minimum of US\$20 to LCIF.
- 3. Determined that Melvin Jones Fellowship or Progressive Melvin Jones Fellowship credit be made available to donors making memorial gifts to LCIF.
- 4. Adopted in a joint session with the Programs Committee basic criteria for approving projects associated with lead gift designations.

FINANCE COMMITTEE

- 1. Approved a decrease of US\$1,203,188 to the operating budget for fiscal year 2020-2021.
- 2. Approved a decrease of US\$798,634 to the overall capital fundraising campaign budget.
